- Provide and maintain plant, equipment and systems of work that are safe and without undue risk to health
- Provide health and safety training instruction and information to ensure that people are competent to safely undertake the tasks and duties assigned
- Ensure emergency response procedures are effective to prevent personal injury and damage from potential incidents

ENVIRONMENT

- Identify significant aspects of all appropriate activities, introducing analysis based on life cycle and carbon footprint.
- Specify and implement resultant control measures in order to eliminate or minimise the potential for pollution and environmental impact
- Implement a programme for adaptation to climate change, by anticipating adverse effects and taking appropriate action to prevent or minimise the impact.
- Mitigate Climate Change by taking measures to prevent or reduce the emissions of greenhouse gases (GHG).
- Ensure appropriate assessment, treatment and elimination of wastes in accordance with the European Waste Hierarchy
- Identify opportunities to optimise energy & fuel consumption
- Provide environmental awareness training empowering our employees to contribute in improving our environmental performance

QUALITY

- Determine customer requirements and expectations in order to supply right first time.
- Ensure in process inspection procedures are effective to prevent the supply of nonconforming
